Sir,

In producing herewith four (06) accused persons namely (1) Bittu Khan (24 yrs,) S/O Late Moti Khan of New Ambedkar Colony, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling, (2) Sunil Malik (27 yrs), S/O Mahesh Malik of Biswas Colony, PS- Matigara, Dist.- Darjeeling, (3) Rabi Chakraborty (34 yrs), S/O Kuchan Chakraborty of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling, (4) Rajesh Chakraborty (38 yrs), S/O Kuchan Chakraborty of Ratanlal Busty, Ward No-01, PS- Pradhan Nagar, Dist.- Darjeeling, (5) Pawan Biswakarma (25 yrs) S/O Prem Biswakarma of Chanapatty, PS- Siliguri, Dist. Darjeeling and (6) Pankaj Singh @ Panka (29 yrs), S/O Late Ramasish Singh of Gurung Busdty Bazar, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following articles under seizure viz :- (i) one mylti colour nylon bag, (ii) one blue and black colour plastic torch light, (iii) one iron made sharp cutting weapon locally called as "Hasua" measuring 22 inches in length including its wooden butt, (iv) one iron made sharp cutting weapon lacally called as "Dagger" measuring 15 inches in length, (v) one iron made hammer with wooden butt measuring 10 inches in length, (vi) one iron made weapon locally called as "Sabol" measuring 22 inches in length and (vii) one iron made weapon locally called "Dau" measuring approx 17 inches in length. I, ASI Prabal Sarkar of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 06 (six) arrested accused persons and their 04/05 unknown associates who involve in this crime to the effect that on 24.09.2024 at 00.15 hrs received a specific source information that about 10/11 miscreants equipped deadly weapons assembled in a Himachal Colony, Quarter Building under PS- Pradhan Nagar, Dist.- Darjeeling and are taking preparation for committing Dacoity at Himachal Colony and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1389 dated 24.09.24. As per your kind order and direction at 00.25 hrs. I accompany with SI Goutam Mallik, ASI Biplab Kr Das, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Himachal Colony under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. This refers to Pradhan Nagar PS GDE No 1390 dated 24.09.24. I also informed one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over mobile phone and requested him to come to Himachal Colony for the purpose of videography if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer SI Pranab Kr. Singh of Pradhan Nagar PS and requested him to come to Himachal Colony to accompany with us. At around 00.45 hrs we arrived at Himachal Colony and after a while SI Pranab Kr Singh and the above mentioned videographer reached there and accompany with us. I briefed them properly. Then, I contacted with my source while he pointed the abandon Railway Quarter situated at Himachal Colony under PS- Pradhan Nagar, Dist. -Darjeeling. Then, I requested two independent witnesses namely (i) Md. Nayim (40), S/O Late Minodin of Adarsh Nagar, W/No. 06,PS. Siliguri, Dist. Darjeeling and (ii) Gajendar Kumar (35), S/O Kishanlal of gate bazaar, P.S. New Jalpaiguri, Dist. Jalpaiguri and I shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards the abandon Railway Quarter being pointed by the source and cordoned the place with due care and cautioned and from a considerable distance we noticed that some persons were inside the said Railway Quarter and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot by crossing broken window of the quarter but on hot chase we managed to apprehended above noted six (06) accused persons while 04/05 others managed to fled away from the spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered one multi colur nylon bag containing the weapon of offence mentioned in Sl. No. (ii) to Sl No (vii) from their joint possession.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 04/05 of their associates assembled there and were making preparation for committing Dacoity at Himachal Colony and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 02.28 hrs to 03.15 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.-Darjeeling as per norms of BNSS and brought all the six (06) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted six (06) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at Himachal Colony and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of Law against may kindly be started against the above noted six (06) arrested accused persons namely (1) Bittu Khan (24 yrs) S/O Late Moti Khan of New Ambedkar Colony, Ward No-01, PS-Pradhan Nagar, Dist.- Darjeeling (2) Sunil Malik (27 yrs) S/O Mahesh Malik of Biswas Colony, PS-Matigara, Dist.- Darjeeling (3) Rabi Chakraborty (34 yrs) S/O Kuchan Chakraborty of Ratanlal Busty, Ward No-01, PS-Pradhan Nagar, Dist.- Darjeeling (4) Rajesh Chakraborty (38 yrs) S/O Kuchan Chakraborty of Ratanlal Busty, Ward No-01, PS-Pradhan Nagar, Dist.- Darjeeling (5) Pawan Biswakarma (25 yrs) S/O Prem Biswakarma of Chanapatty, PS-Siliguri, Dist. Darjeeling (6) Pankaj Singh @ Panka (29 yrs) S/O Late Ramasish Singh of Gurung Busdty Bazar, PS-Pradhan Nagar, Dist.- Darjeeling (i) Shiba Barman @ Bau (24 yrs), S/O Dilip Barman of Durgaguri, Kalibari road, PS-Pradhan and others 06/07 unknown miscreants and arrange for its investigation.
