- I, Sri Rajesh Kumar Agarwal, S/o M.K. Agarwal, having my office at R.K. Agarwal, S.P. Mukherjee Road, Khalpara, P.O. & P.S. Siliguri, District -Darjeeling do hereby inform you as follows:
- 1. That on 12.09.2024, the High Court at Calcutta, Circuit Bench at Jalpaiguri has passed an order in a Writ petition filed by my wife Bela Agarwal against Siliguri Municipal Corporation being WPA 1947 for the year 2024 for conducting physical inspection in my building at Burdwan Road.
