**Subject:- Written Complaint**

Respected Sir,

I, RANJAN KUMAR ROUTH, s/o - Sri Mahendra Routh, resident of Ganga Nagar Rani Sati Mandir Road Ward No.5, P.O- Siliguri Bazar, P.S- Siliguri, District - Darjeeling, Pin -734005, West Bengal, would like to draw your kind attention towards following facts:-

1. That on 24th September, 2024 one of my friend namely Bijay Sahani S/o - Not Known resident of Ganga Nagar Road No.2, Nepali Busty Road, called me over phone and told me that he will kidnap One boy namely Asish Jaiswal who happened to his friend and also threatened me that if I came in their way or tried to inform Ashish about the same then it will be not good for me.
2. That the said Asish Jaiswal is one of my relative and after listening the same I anyhow secure him and sent him at his house.
3. That at about 12:40 am approx, when I was going to my house, and when I reached to the Santoshi Nagar More my same friend Bijay Sahani was standing there and told me to stop and I stopped there.
4. That when I stopped there, suddenly the same Bijay Sahani S/o - Not Known resident of Ganga Nagar Road No.2, Nepali Busty Road and 2(Two) other famous criminals of that area namely Prashant Singh, S/o - Guddu Singh, resident of Ganga Nagar Near Marble Raj and another one Bikash Jha @ Chumma, s/o - not known, resident of Matigara, Kholabaktri, came and started abusing me and biting me with leather belt and iron rod on my head, and stomach area and back side of my body.
5. That I was helpless as because there was no any person available there from whom I could sought any help to save me.

6. That were continuously assaulting me and heating me with belt and iron rod in very brutal manner, suddenly some passersby were going from that side they saw us and after seeing them those miscreants flew away from the spot threatening me that they will make sure to kill me anytime.
7. That after that those persons who were passing through that side took me to the Siliguri District Hospital, as I was in very bad condition the hospital authority advised me to get admitted and I do accordingly and on 24th September, 2024 i got discharged at about there 1:31 pm and that is why I was unable to inform the matter before the police station.
8. That my CT Scan was done by the Doctors and report for the same is expected to be deliver on 25th September, as informed by the doctor, at the time of discharge doctor aslo advised me to take rest and also given me some medicine.
9. That it is pertinent to mention herein that these miscreants are involved in extortion, kidnapping, and in other serious criminal offenses and many other criminal cases is pending against them.
10. That it is my assumption that as I have been a major reason of failure of their plan of kidnapping of the said Asish Jaiswal, they were not happy with me and for the same they have attacked me in this way. Now I am in very worried condition that they have threatened me to kill me.
11. That on the above-mentioned circumstances I prayed before your good office to kindly lodge Written Complaint against this miscreants and take proper steps as soon as possible as per penal provision of law.

This is for your information and necessary action and For this i will be very grateful to you.
