Sub: First information report regarding one cognizable offence happened against me and my family.

Respected sir,

With due respect I Mr. Ratan Paul son of Late Rabindranath Paul, aged about 60 years resident of 40, Haren Mukharjee Road, Hakimpara, po & ps Siliguri, District Darjeeling, pin 734001, do hereby inform you about the following :-

1. That I earn my livelihood by running a stationery and grocery shop, owned by my mother in law Late Ava Rani Das, along with my wife Mrs. Kakali Paul aged about 52 years at Hakimpara, Haren Mukharjee Road, near Vivekananda club.
2. That as usual on 23rd September 2024 I along with my sick wife running our shop named "Shasti stores".
3. That on 23rd September 2024 at about 10:15 p.m. one customer named Samiran Das @ bulu son of late Subodh Das resident of Hakim para came to our shop and without our permission he fetched one paper boat juice which was lying on the top of our fridge in front portion of our shop and refuse to pay the price of rupees 10 /-.
4. That on hearing the above my wife reminded him about his previous due/ arrear of rupees 10/- for 1 lighter which he bought day before yesterday and payment was due. Further my wife politely reminded him that till now he has to pay rupees 20 /- in total.
5. That after hearing the above Samiran Das got angry and started threatening me and my wife by saying that he will kill me and my wife by shooting us with a gun and started misbehaving with my wife with very bad slang words and abusive words.
6. That along with such abusive words he started throwing goods from our shop on roads like biscuits, chips packets, Water bottles etc and started kicking punching at different items of the shop and continuously threatening me and my wife with our life and continuously dishonoring us.
7. That we along with other customers present try to keep him calm but all in vain. One Jibon Ghosh, Sunny (phn no 7432806431) and other customers cum friends captured him and accompany him to his home at Hakim para.

8. That as we are aged people we got scared so we called our only son Rickky Paul over phone, as a result he came to the shop to consolidate us at about 10:35 p.m.
9. That as our son was consolidating us Samir Das again came with the wooden "balloon" at our shop and started arguing with us, voluntarily, and again threatening us with our life.
10. That my son ask him to leave the place and go home but he started fighting with my son and rashly by using criminal force hit my son with his head which grievously hurt my son on his nose / nasal Bridge. As a result my son suffered from massive blood loss and damaged / fractured nose bone and fall on the ground. My son was badly injured.
11. That on seeing this some neighbors rushed to our rescue and tried to stop Samiran from beating my son.
12. That after that my wife and my son went to your Fari for initial reporting of the incident and rest is within your knowledge
13. That at 11:30 p.m. we took our Son to district hospital Siliguri where the OPD doctor admitted him as my son's condition was very critical.
14. That today that is 24/9/2024 doctor on duty at the hospital told us that his condition is very bad and it will take time for full recovery and it is a sports injury. His blood pressure is 90 by 60 due to massive blood loss and his nose bone is badly damaged fractured and it needed stitching. My son now admitted at district hospital Siliguri and he has to be there for few more days. He may need further expert treatment for full recovery.


Therefore on the above mentioned facts and circumstances I am requesting you to bring the above named accused under the book of law and do justice and do the needful and oblige
