we reached at Santoshi Nagar more, two
person namely ① Ranjan Rout, s/o. Mahendra
Rout and ② Sushil Choudhury, s/o. Not known
both are resident of Ganga Nagar, w/No. 5. P.S.
Khalpara and they restrained us and both
of them were drunk and they started to
abuse us and I opposed them, both of
them started to assault me with fist and
blows and when my friends above noted
tried to rescue me they both of them with

bamboo lathi started to assault my friends too. and when they again opposed the same act they again started to beat them brutally with bamboo lathi in their head and when both

of them became unconscious they came towards me and one of them pushed me down to the road and holded my hand and both of them started to search my pockets and they took Rs 11,000/- (Eleven thousand) which was kept in my money bag and also they took one gold finger ring forcefully from my finger and when I shouted for help they pressed my mouth and again started to assault me and also threatened me. If I lodged any complaint they will kill me. and they both of them ran away from the spot.

Therefore finding no other alternative way today I lodged this complaint before you against
① Ranjan Rout and ② Sushil Ghoshung and take necessary legal steps as soon as possible.
