marriage was solemnized with Soham

and customs. After my marriage I  
was brought by my husband and in-  
to my matrimonial house at deshbondh  
para and started leading my marit

relation with my husband. During stay at my matrimonial house, on several occasions I saw that my husband is habituated to become naked before his mother Smt. Jagati Sankar and my mother-in-law used to massage the penis of my husband and he is habituated of masturbating to discharge. Even he always neglected to maintain physical relation with me. After seeing said activities of my husband and mother in law, I have raised my objections. Upon the said issue, my husband and mother-in-law have started physical and mental torture upon me. On several occasions I was mercilessly been assaulted by my husband and mother in law with threatnings not to disclose the said fact. During my stay at my matrimonial house, my husband could never satisfied my

physically rather he used out his  
semen by masturbating in front  
of me which was more painful for  
me not only that, he never bear any  
liability towards me and never gave  
me any furtherance for my personal  
expenses. On 22nd August 2024 my  
husband and mother in law brutally  
assaulted me and out me from the  
house in single clothings. Finding no  
other alternative, I called my father  
and returned back to my parental  
house. During my stay at my parental  
house though I have tried to go to my  
matrimonial house by sending the mediator  
but the above named persons have  
insulted them and them back. Today  
morning ~~at~~ I went there too but I was  
not allowed to enter, they brutally

insulted me, shouted upon me. As I was hopeful the matter may be amicably solved but my husband and mother in law do not want to continue any relation with me when the mediators informed me about the intention of the above named persons. Since the day of marriage I was subjugated to mental and physical torture from the end of my husband.

So, requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
