With due respect, I am producing herewith the 04 (four) arrested accused persons namely (i) Bishal Das (19), uman Das of Beldangi, Near Shani Mandir, PS- Matigara, Dist- Darjeeling, (ii) Jiban Roy (20), S/o- Habul ofoldear Sabita Bhawan, Ghughumali, Ashighar, PS- Bhaktinagar, Dist- Jalpaiguri, (iii) Ratan Mohanto (24), S/o- Mona Mohanto of Nischintapur Tea estate, PS- Matigara, Dist- Darjeeling and (iv) Harihar Barman (20), S/o-Amal Barman of Rabindra Nagar, Patiramjote, PS- Matigara, Dist- Darjeeling and the following articles under seizure :-

- 1. One torch light and one iron rod used for lock breaking measuring approx 1'5" from the possession of accused named Bishal Das.
- 2. One iron made sword measuring approx 3 feet with wooden butt from the possession of accused named Jiban Roy.
- 3. One iron rod measuring approx 2 feet from the possession of accused named Ratan Mohanto.
- 4. One iron rod measuring approx 2'5" from the possession of accused named Harihar Barman.

I, ASI Pema Dorjee Sherpa of Matigara PS, Siliguri Police Commissionerate beg to state that on 24.09.2024 at 23.35 hrs, received a secret source information that a gang of miscreants were assembled at Phansidewa More Rly. Underpass, near Rail line, PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Shibmandir area. Accordingly, I informed the fact to I/C, Matigara PS and diarized the matter vide Matigara PS GDE No.1379, Dated- 24.09.2024. As per his kind order myself along with ASI Dhirendra Nath Mandal, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar, C/868 Sujal Roy all are of Matigara PS, Siliguri Police Commissionerate left for Phansidewa More Rly. Underpass, near Rail line, PS- Matigara, Dist.- Darjeeling to work out the information in hand. At about 23.45 hrs on 24.09.2024 we arrived at Phansidewa More Rly. Underpass, near Rail line under Matigara PS. After arrival at the spot and as identified by the source we found that 10/12 persons were assembled at the under pass near Rail line and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we managed to apprehended 04 (four) persons. On interrogation the apprehended accused persons disclosed their name and identity as noted above (not verified) and also disclosed that they assembled there for making preparation for committing dacoity at Shibmandir area. They also stated that others 06/08 associates were able to fled away from the spot by taking advantages of darkness. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 04 (four) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest was made in between on 24.09.24 at 23.50 hrs to on 25.09.24 at 00.25 hrs. Due to mid of the night and heavy rainfall, there was no person to whom I request for act as an independent witness. The whole process of seizure was made under videography.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Bishal Das (19), S/o- Suman Das of Beldangi, Near Shani Mandir, PS- Matigara, Dist- Darjeeling, (ii) Jiban Roy (20), S/o- Habul Roy of Near Sabita Bhawan, Ghughumali, Ashighar, PS- Bhaktinagar, Dist- Jalpaiguri, (iii) Ratan Mohanto (24), S/o- Mona Mohanto of Nischintapur Tea estate, PS- Matigara, Dist- Darjeeling and (iv) Harihar Barman (20), S/o- Amal Barman of Rabindra Nagar, Patiramjote, PS- Matigara, Dist- Darjeeling and others and arrange for its investigation.
