
Dear Sir,

I, Sri Mukesh Sharma, S/o. Madanlal Sharma, resident of PCM House, Sevoke Road, Siliguri, working as Site Manager/Caretaker at PCM House, Sevoke Road, Siliguri for looking after the day to day renovation work of PCM House, would like to inform you that today at around 9.30 am when I resumed my duty, I found that many items like Electric Wires, Copper Pipes, Air condition fittings and others were stolen from our site. I presume that such incidence of theft was occurred during yesterday night i e, on 23.09.2024 night through the back side of the house by cutting the barbed wires & wire nets on the wall. It is also to inform you that the owners of PCM house are presently out of station and the theft of other items, if any, can be assessed only after their arrival.


It is also to inform you that M/s. Pahari Security Service of Shivmandir was engaged for the security of PCM House for last few years and yesterday night the following guards were on duty 1.
