Sub: Complaint against my father-in-law, Karna Bahadur Chhetri, Son of not known, brother-in-law, Raju Chhetri (Chottu), Sontosh Chhetri (Santu), both are son of Karna Bahadur Chhetri, Leela Subba (Doly), Wife of Raju Chhetri (Chottu), Krishna Maya Chhetri (Kalpana), Wife of Sontosh Chhetri (Santu), Manisha Chhetri, Daughter of not known, Roshni Subba (Biswakarma), Wife of Suraj Chhetri, all are resident of Salugara Bazar, Ward No.42 of SMC, P.O. Salugara,, P.S. Bhaktinagar, Dist. Jalpaiguri.

Respected Sir,

I, **SMT. SANGITA CHHETRI**, Wife of Sri Sanjoy Chhetri, residing at Salugara Bazar, Ward No.42 of SMC, P.O. Salugara,, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my, my father-in-law, Karna Bahadur Chhetri, Son of not known, brother-in-law, Raju Chhetri (Chottu), Sontosh Chhetri (Santu), both are son of Karna Bahadur Chhetri, Leela Subba (Doly), Wife of Raju Chhetri (Chottu), Krishna Maya Chhetri (Kalpana), Wife of Sontosh Chhetri (Santu), Manisha Chhetri, Daughter of not known, Roshni Subba (Biswakarma), Wife of Suraj Chhetri, all are resident of Salugara Bazar, Ward No.42 of SMC, P.O. Salugara,, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effects as follows:-

- (1) That my marriage was solemnized on 08-12-2013 along with said Sanjoy Chhetri of Salugara Bazar, Ward No.42 of SMC, P.O. Salugara,, P.S. Bhaktinagar, Dist. Jalpaiguri and after the marriage I lived and cohabitated with my husband at my above-mentioned matrimonial home/shared household along with my in-laws.
- (2) That out of the said wedlock, I gave birth to a female child namely Niyati Chhetri on 20-12-2014.
- (3) That since after my marriage, my in-laws frequently abuse me in filthy languages and commit torture upon me both mentally and physically. They did not provide electricity in my shared household, prohibited to use bathroom and toilet and other essentials and on several occasions threaten me to leave the share household. To drive me out of my matrimonial home,

they burst chocolate bombs at the door of my shared household and uses various means and hurl abuses upon me by openly saying me prostitute (randi) and assassinates my character. They also had physically assaulted me at the time of my pregnancy. For the sake of prestige and reputation of my in-laws in the society, I tolerated all the above stated cruelty all these days.

- (4) That on 22-09-2024 at about 6:00 pm, my in-laws above-named hurl verbal abuses upon me by openly saying randi to me and assassinated by character. They also physically assaulted me with slaps, fists and blows and kicks and caught hold of my hair and dragged me on the floor. My brother-in-laws named above used force to outrage my modesty and tore by nighty and disrobed me and when my husband came to save me, my in-laws also physical assaulted him with slaps, fists and blows and kicks. They also threatened me that they will cause untoward incident upon me.
- (5) That due to their physical assault, I sustained bleeding injuries on my lips, forehead and all over my person and my husband also sustained injuries on his face and all over his person.
- (6) That my in-laws are very desperate in nature and dangerous persons having no regard to the law.

So, therefore, I humbly request you to take stringent legal action against my in-laws and booked them under specific provision of law at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
