Dear Sir.

This is to inform you that my daughter is being teased and threatened by a notorious Girl and her peers. Namely Ayesha, Muskan, Simran, and Afridi. They target my daughter generally at the road, while she return from tution. They had several quarrels and fights regarding a peculiar incident that occurred on 15th August 2024. The Girl named Ayesha suddenly approached my daughter and showed a photo where she was kissing a boy, who happens to be my neighbour. She proposed me to help her regarding a plan to blackmail the boy with her friends and sisters. My daughter refused to interfere in someone's matter with an intention to tarnish the image, which is unethical and non of her business, she refused and asked her to leave.

Later we came to know that the Girl made the photo viral in social media groups.

Last on 23rd September, they again ghearowed my daughter and assaulted her on way to back home near Iskcon temple Gate No.2.

I was in my Chamber , my wife called me up and narrated the incident. It was 9:20pm , when I reached my home, a big mob was waiting, when I asked the girl's Father what happened, Md. Amin and his son Afridi became furious and pushed & assaulted me.

The dadagiri unlimited left me unsafe and we went inside the house and reported verbally to your PS.

We did not complain as the on-duty Officer assured us that they will make a detailed enquiry.

Today, I have logged an FIR mentioning the entire incident as my minor girl child is feeling unsafe to go outside the house.

She is in trauma and helpless as the girl and her group is in habit of making social media scams with Morphed Images of Girls and boys, later blackmailing the innocent youths to comply according to their illegal ends.

I hope it is a severe crime and anticipate immediate legal action. rimmediate legal action.
