Husband.

Dear Sir,

I Jayati Dalai wife of Sanjay Dey address
Jaleswari bazar main road, hatigadanga 4/2,
Sahudangihat, Pin-735135, Dist - Jalpaiguri. I have
been in a marriage 8 years. My registry marriage
was on 20/7/2017 and social marriage was on
30/1/2020. After 1 year of registry marriage my
husband beaten me for the first time, and when
my family asked him for the reason he and
his family told that he is in high pressure of
work and building the house were we going to
live after our social marriage. My family didn't
took any action against my husband due to face
loss in society. But after the social marriage, domestic
violence incidence increased. My mother-in-law used
to mentally harassed and abuse me and my family.
Whenever I told these things to my husband he
used to get angry and beat and abuse me. I faced
these domestic violence since 3 years. On 18 August 2024
at 9 am. I told my husband to help me with some
household works, and then I went out in the garden
were we wash clothes. Suddenly my husband
came running and started beating me with a
wooden block at my back, when I turned around

e punched me continuously on my face by which my nose got broke. After beating me he went to his daily work as he went out, I took my child and came to my mother's house - Rly Institute colony behind new cinema hall, ward-28 PS - Siliguri Town, Pin - 734004, Dist - Darjeeling. I was admitted in Siliguri District Hospital on 5/9/2024 for my nasal bone fracture operation which was done on 6/9/2024 and got discharged on 8/9/2024. After recovery today 27/9/2024 I want to report a FIR against my husband.

I would appreciate it if you could look into this situation as soon as possible. I have attached all the medical documents of mine.
