Respected Sir,

With reference to the above, I would like to state that on the night of 26/27-09-2024, some unknown persons committed house trespass and stole cash amounting to Rs. 7,000/- (Rupees Seven Thousand), one Samsung phone, one realme phone and an iphone valued at approximately Rs. 1,40,000/- (Rupees One Lakh Forty Thousand). The theft occurred by opening a window with the help of a stick from my first floor room. The stick used in the crime and a lady's bag containing cash were left behind by the miscreants on the terrace of the building.

It may kindly be noted that the apartment where I reside belongs to my uncle, Dilip Kr. Das, and is located at Middle Shanti Nagar, near Shanti Nagar Sporting Club, under Ashighar OP, PS Bhakti Nagar, Dist- Jalpaiguri.

To the best of my knowledge, the culprits have committed offences punishable under Sections 331(4) and 305 of the BHARATIYA NYAYA SANHITA, 2023. A few days ago, two individuals were spotted walking across the lane in front of our house in a suspicious manner during odd hours of the night. One of them appeared to be a minor.

I, therefore, request that necessary action to be taken as per relevant sections of the law.
