Sri Sakét Agarwal son of Narendra Agarwal residing at Jalpai More, P.O & P.S-Siliguri, Dist.-Darjeeling do hereby lodge this written complain stating that construction is going on over my land situated within the boundary On the North :: Land of Baijnath Goyal; On the South :: Land of Lama Babu & others; On the East :: 16ft wide Private road; On the West :: Zilla Parishad Raod since from last year. That on yesterday (26.09.2024) at about 11.30 am some miscreants under the leadership of one Rajesh Chhetry (as disclosed his name) came in front of my construction area and directed my labours to stop construction and also demanded money for such construction. That after some moment all of them forcibly tried to enter into my construction area by breaking the gate and on being chased by my security guard all of them fled away from the spot after that at about 1 p.m said Rajesh Chhetry and his associates again came in front of the construction area and demanded money at that time they have also threatened that within in three days if I did not fullfill their demand they will not hesitate to shade blood.

That in this circumstances I pray before you to take appropriate steps against the above noted miscreants and his associates and obliged thereby.
