Dear Sir,

With due respect, I, Papari Jury, wife of
Raju Jury would like to inform you that I was mar-
-ried to Raju Jury on 28th August, 2006 in Kalibari
Temple S.F. Road and after registration done. After one
year of marriage he started to torture me physically
as well as mentally. I tried my best to adjust
thinking about the social status and my daughter's
future. But the thing became worst from 31st July
2024. On that day he had beaten me on my back
using steel thick stick and throttled me that I
wasn't able to breathe properly, somehow my
daughter, Prachi Jury, saved me by pushing
him. Then he had beaten my daughter too. Every time
he tortured me whenever he drunk, I was in
severe backpain as my two discs (backbone)
bulged out due to this and completely bed
ridden and also admitted in Anandolek Hospital
Kora from 24th August 2024 to 30th August 2024.
I had send email to write FIR to Umer Police
Station three times from 31st August 2024 as I
couldn't sit, walk and stand properly. After
this incident he used to stay with his family
and continuously threatening me to kill me if I will
take legal action.

Hence it's my kind request to look into the matter
and protect me and my daughter from him.


