Sir,
I, Sri Bajrang Lal Sharma, Son of Satya Narayan Sharma, resident of
Ganga Nagar, Ward No. 5 of S.M.C., Post Office & Police Station
Siliguri, District Darjeeling, would like to inform you as follows :

1. That on 28.08.2023 I lodged one missing diary before your
Police Station in respect of missing of my wife and two children,
but your Police Station failed to recover my wife and two
children.

That very recently I came to know that on 26.08.2023 at night
the Guddu Balmiki (Chawaria) and his mother of Burdwan
Road, Ganga Nagar, Road NO. 1, Balmiki Basti, Ward NO. 5 of
S.M.C., Post Office & Police Station Siliguri, District Darjeeling,
took my wife and two children at Rajasthan and now they are
staying at the house of his Jamai Babu namely Binod Balmiki
(Phone No. 82098-97695) and on several occasions we made
several attempts to contact with my wife and children over
telephone, but all are in vain and we did not know the actual
place at where they are staying now.

3. That we are apprehending that said Guddu Balmiki and his
family members took away my wife and children for the purpose
of human trafficking and for that reason they are not disclosing
their actual address.

Therefore, I humbly request to you to look into this matter and
to do proper investigation and to recover my wife and children
from the custody of the abovenamed accused persons and to
take necessary legal action against them and this is also
mentioned here that the mother of the Guddu Balmiki is the Ex-
employee of Siliguri Municipal Corporation and she is
withdrawing her pension from the jurisdiction of Siliguri.
