SUBJECT:- Complaint against Extortion and Threats by Land Mafia members

Sir,

I, Suresh Kumar Agarwal, aged about 64 years, son of Late Kundan Mal Agarwal, am currently residing at Maa Shakti Weigh Bridge Compound, Eastern Bypass Road, Opp. Himalayan Kanya Abasan, Siliguri. A person by the name of Himadri Sarkar (Bubai), has been trying to extort money and threaten me for the past 1 month, on account of a land (4 kathas), situated near Maa Mahalaxmi Weigh Bridge. The said land is registered in the name of Mr Rajesh Agarwal and Mr Sushil Mitruka (not in my or my immediate family member's name).

Mr. Dev Vijay Kumar Agarwal and his wife Sunita Agarwal, both of Shreekanta Apartment, Ashrampara, P.O. and P.S. Siliguri, Dist: Darjeeling- 734001, are claiming to be the owners of 30 kathas of land (which includes the above mentioned 4 kathas and 8.5 kathas land adjacent to it). The said Himadri Sarkar claiming to be their authorized representative, on their behalf, has threatened me 3-4 times over phone (from mobile no. 8145788123), warning me to either pay up or face dire consequences on my life. He has also sent me a photo of a false complaint to Ashighar P.S. outpost over whatsapp and an audio clip on 11/9/24, 2 weeks well before making an official complaint with a view to legally harass me.

I want to inform you that they operate on the same modus operandi of filing false FIR and court cases, and then using anti-social elements into pressurizing the land owners to pay them and settle cases, with me being a victim to a similar episode that happened in 2017, with the said Mr Dev Vijay Kr Agarwal and Sunita Agarwal.

A land of 8.5 kathas (adjacent to the 4 kathas mentioned above), was earlier registered in the name of Radheya Properties Pvt. Ltd., and I was it's former Director. The said Mr Dev Vijay Kr Agarwal and Sunita Agarwal, had similarly filed a false FIR in Ashighar P.S. outpost (GDE no. 281 of 16/9/17) and a T.S. no. 153 of 2017 under Japlaiguri Court. To put an end to the harassment, I had paid them a sum of Rs. 2 lakhs (acknowledged by them in court prayer). The above case was dismissed for their default on 20/12/19.

As you can notice, they are trying to use similar methods of threatening, lodging false FIR and court cases, into harassing and forcing the victim to pay up.

The said land of 4 kathas, is already under court litigation (T.S. no. 278 of 2023 dt 6/5/23). I am not a party to this case. But expecting a similar payoff, they have included my name too in the complaint to Ashighar PS outpost vide GDE no.

Kindly note that having undergone a stent placement for an episode of Myocardial Infarction, which I suffered on 1st May of 2024, I would not indulge into such activities as alleged in the false complaint of the said Himadri Sarkar.

The said Himadri Sarkar, Dev Vijay Kumar Agarwal and Sunita Agarwal are actually a front for Mr Sushil Periwal of Bidhan Market, Siliguri, who has a reputation of being a land mafia in Siliguri.

Hence, I request you to look into this matter and take stringent action on such open intimidation and extortion threats by the above mentioned land mafia members.
