**Subject:** Written complaint for domestic violence, dowry harassment and desertion.

Respected Sir,

I, **Smt. Mridula Chakraborty**, Wife of **Sri Ratan Chakraborty**, Daughter of **Sri Pijush Chakraborty**, a permanent resident of **Asha Kutir, Near I.B. Thapa Memorial Nepali School, Post Office and Police Station - Pradhan Nagar, District - Darjeeling, Pin Code - 734003**, hereby lodge this complaint against my husband and his family members for subjecting me to severe physical, mental, and emotional abuse.

I was married to **Sri Ratan Chakraborty**, Son of **Late Madhusudan Chakraborty**, as per Hindu rites and customs on **10th March 2016**, at Pradhan Nagar, Darjeeling. After marriage, I began residing with my husband and in-laws at **Rasulpur Mango Orchard, P.O. & P.S. Memari, District - Purba Burdwan, West Bengal**. Immediately after the marriage, I was subjected to continuous dowry demands, mental harassment, and severe physical abuse by my husband, **Sri Ratan Chakraborty**, and his family members, viz. **Smt. Arati Chakraborty** (mother-in-law), **Sri. Tapan Chakraborty**, **Sri. Sapan Chakraborty**, **Sri. Chandan Chakraborty** (brother-in-laws), **Smt. Rupali Banerjee** (Chakraborty) and **Smt. Bani Chakraborty** (sister-in-laws) a

My husband and his family members consistently demanded additional dowry, despite my parents having provided substantial dowry during the marriage. They demanded more money and valuable items, causing severe stress to me and my parents.

I was subjected to regular verbal abuses, insults, and physical assaults by my husband and in-laws. My husband, often under the influence of alcohol, used to hurl abusive words, beat me, and threaten my life.

On **7th July 2017**, I was locked in a room by my husband and in-laws and left to starve. I was rescued only after contacting my parents, who sought police intervention.

My husband and his family members have constantly threatened to harm me and my parents. They even threatened to kill my parents during the **Holi** festival in 2017.

I have reasons to believe that my husband is involved in an illicit relationship with a woman named **Tompa Bhattacharjee**, a resident of Siliguri.

I have already filed the following legal proceedings:

- A **matrimonial suit** under the **Hindu Marriage Act, 1955**, for dissolution of marriage on grounds of cruelty and desertion, which is currently pending before the Court of the Learned Additional District Judge (3rd Court) at Darjeeling, registered as **Mat. Suit No. 65 of 2021**.
- An **application under Section 12** of the **Protection of Women from Domestic Violence Act, 2005**, which is registered as **Misc Case No. 84 of 2024** and is pending before the Learned Judicial Magistrate, 1st Court at Siliguri. This application seeks various reliefs, including protection orders, residence orders, monetary relief, and compensation for the prolonged domestic violence inflicted upon me.

I have been residing at my parental home since July 2017, unable to return due to the continuous threats and torture inflicted upon me. Despite attempts to seek police intervention earlier, no formal action was taken, and I was forced to take legal steps to protect myself.

Based on the facts mentioned above, I request you to kindly register this complaint and initiate necessary actions against **1. Sri Ratan Chakraborty**, Son of Late Madhusudan Chakraborty, **2. Smt. Arati Chakraborty**, Wife of Late Madhusudan Chakraborty, **3. Sri. Tapan Chakraborty**, Son of Late Madhusudan Chakraborty, **4. Sri. Sapan Chakraborty**, Son of Late Madhusudan Chakraborty, all Resident of Rasulpur Mango Orchard, P.O. & P.S. Memari, District - Purba Burdwan, Pin Code - 713151, **5. Smt. Rupali Banerjee (Chakraborty)**, Wife of Sri. Amarnath Banerjee, Resident of Ballyganj Kasba, P.O & P.S. Kasba, Dist. Kolkata, Pin Code - 700042, **6. Sri. Chandan Chakraborty**, Son of Late Madhusudan Chakraborty, and **7. Smt. Bani Chakraborty**, wife of Pradip Chakraborty, both resident of Udham Singh Sarani Road, Ward No. 10 of Siliguri Municipal Corporation, Ashram Para, Post Office - Siliguri, Police Station - Siliguri, District - Darjeeling, Pin Code - 734001.

I seek your urgent assistance in ensuring my safety and the protection of my rights as a victim of domestic violence.
