With due respect I BISHAL GUPTA, S/o Munna Prasad Gupta, resident of gupta hardware, matigara bazar, P.O: Matigara, P.S: Matigara, Dist: Darjeeling, 734010 – in the state of West Bengal, had an accident near WEST POINT SCHOOL on 06/10/2024 around 2 pm while coming from courtmore to matigara. While I came across near west point school a taxi car driver suddenly opened his right side front gate on the middle of the road. Due to the hit I have crashed to the adjacent metal road with my scooty. After the incident some local people immediately carried me to the hospital, and after completion of all the x-rays and CT SCAN reports I found there is a bone fracture (broken) in my knee and severe head injury in my head and scratches in my whole body. And I also like to inform you that my scooty also damaged from the front side and right side and now I am admitted to the MOHPAL HOSPITAL for my knee surgery and further medication.
