With due respect, I would like to lay following few lines for favour of your kind consideration and necessary action:

That Sri Praloy Bhattacharjee, son of Late Pabitra Bhattacharjee, resident of Sitala Para at the house of Bishnu Paul Chowdhury as a tenant, P.O. Siliguri Town, District Darjeeling induced me to marry him by saying that he is a conductor of a Bus namely Aarati and also used to state that he has huge money in his Bank Account. Praloy also used to say that he will give me all facilities as a Queen after marrying him.

That my marriage with Sri Praloy Bhattacharjee was solemnized on 22/04/2015 at the house of my maternal Uncle Sri Sushil Paul, situated at Village Abuar Pathar, P.O. Shib, P.S. Sitalkuchi, District Cooch Behar as per Hindu rites and customs and my mother and other relatives gave many articles like gold and silver ornaments, furniture, clothes, watches, etc. as dowry as demanded by Sri Praloy Bhattacharjee.

That after completion of all marriage formalities my husband Sri Praloy Bhattacharjee brought me to his rented house owned by Sri Bishnu paul Chowdhury but he was not satisfied with the articles given during my marriage and started torturing me both physically and mentally and used to ask me to bring money from my mother for which my mother gave two totos to Sri Praloy Bhattacharjee to make him happy and satisfied but he did not stop torturing me.

That my mother got a plot of land measuring 2(two) Kathas comprised in Plot No. 391 (R.S.), recorded in Khatian No. 778/20, situated within Mouza – Dabgram, P.S. Bhaktinagar, District Jalpaiguri for Rs.1,80,000/- (Rupees one lac eighty thousand) only transferred in my name from Smt. Jhuma Patro (Saha) of Adarsha Nagar, Siliguri on 08/02/2016.

That my mother also constructed a house with brick walls and tin shed roof at the above mentioned land for me after taking financial assistance from many relatives and friends.

That inspite of all these my husband Sri Praloy Bhattacharjee has not satisfied and used to beat me brutally.

That out of the lawful wed-lock a son Ishan Bhattacharjee born to me on 10/10/2017 at Heritage Hospital but all expenditures of delivery were born by me mother and my husband did not bother to pay a single farthing.

That my said son died on 19/10/2023 due to sickness but my husband did not take any care of my son rather he became happy and he did not come to attend the death anniversary of my son not did he allow any other known persons to attend the same at Baba Loknakth Mandir, Dagapur.

That my husband Sri Praloy Bhattacharjee kicked me out of my house on 29/11/2023 and did not allow me to take any thing even my clothes and since then I am living at the address given hereinabove at the mercy of my mother and other relatives.

That Sri Praloy Bhattacharjee is trying to sell and transfer the house standing in name and his antisocial friends are also helping him. Praloy Bhattacharjee is a habitual drunker.

That Sri Praloy Bhattacharjee has cheated me and committed fraud upon me and I apprehend danger to my life for which I am compelled to lodge this First Information Report.
