Sir,

I, Sri Shikha Roy, W/o Sri Dhiren Roy, resident of Bagdogra Station more, Ganesh Bhandar, P.O & P.S: Bagdogra, Dist: Darjeeling, Pin Code: 734014 want to file a complaint against (1) Smt. Manashi Roy Choudhury, D/o Late Nilkamal Roy Chourdhury, W/o Dhiraj roy (2) Sri Biswajit Roy Choudhury, S/o Late Nilkamal roy, (3) Smt. Jayanti Roy Choudhury all residents of Madarihat, Ward No.1, Ambika Nagar, P.O & P.S: Madarihat, Dist: Alipurduar (4) Sri Liton Saha and two unknown persons.

In and around January 2024, my son i.e Sri Dhiraj Roy married abovenamed Smt. Manashi Roy Choudhury and subsequently Smt. Manashi Roy Choudhury started to torture me and my son and she also physically assaulted me and my son on several occasions. Thereafter, in and around the month of July – August abovenamed Smt. Manashi Roy Choudhury left our house with her belongings including her ornaments and clothings and started to reside at her parental house.

In the meantime, my son and other family members tried their level best to convince abovenamed Smt. Manashi Roy Choudhury to mend her ways and continue her matrimonial life with my son. On one occasion my son and other family members even went to her parental house at madarihat to bring her back but was nonetheless they were abused and assaulted and came back feeling insulted finding no alternative.

Today, i.e on 04.10.2024, the abovenamed persons i.e (1) Smt. Manashi Roy Choudhury, D/o Late Nilkamal Roy Chourdhury, W/o Dhiraj roy (2) Sri Biswajit Roy Choudhury, S/o Late Nilkamal roy, (3) Smt. Jayanti Roy Choudhury all residents of Madarihat, Ward No.1, Ambika Nagar, P.O & P.S: Madarihat, Dist: Alipurduar (4) Sri Liton Saha and two unknown persons came to our house at Bagdogra Station more, Ganesh Bhandar, P.O & P.S: Bagdogra, Dist: Darjeeling, Pin Code: 734014 in and around 4.30 PM in the evening and sought permission from me that Smt. Manashi Roy Choudhury wanted to meet with me and my son to mediate their matrimonial issue. But

when I open the door and let them inside my house, they all forcefully rushed persons started beating my son and me and thereafter demanded the keys of the Almirah. My son being in fear of the situation and the number of persons in our house, gave the key to Smt. Manashi Roy Choudhury and then she opened the almirah and took all the gold ornaments which were there (approx 15 the almirah and another Rs. 1,58,000/- (Rupees One Lakh fifty Eight thousand only) in cash and then further Sri Biswajit Roy Choudhury slapped me and dragged me outside the room of my son and thereafter they again started beating my son and on my cry for help and all the noises they fled away from my house threatening me that they will implicate me and my son in false cases.

I am still in shock of what happened and I fear that they will come again and kill us. Also, my life savings are all stolen by these persons. Kindly take strong action and help me get my things and money back.
