I, Sayan Sadhukhan, S/o Harimohan Sadhukhan, AE & Station Manager, NJP Gate Bazar CCC would like inform you that one Pole has been broken being hit by a Car with Registration number: WB 74BN 6991 (in name of Sonali Ghosh, as informed) near Sipai Para under NJP Gate Bazar CCC on dated 09.10.2024. The total cost involved in rectification of the damage caused by the car is Eighteen Thousands only (Rs. 18000.00/-).

The accident was caused due to the reckless driving of the car and as a result of which one 8 meter was broken and approx 30 consumers were in no power due this sudden breakage of pole.

However the pole has been replaced on urgent basis and now the total network is normal.
