Subject:- FIR against Vehicle No (Scorpio):- WB20 / AG2119 due to broken of 8 Mtr PCC poles on our LTOH line and damage of electrical installation of WBSSEDCL at Baikuntha pally (near Kali Mondir) , Dis:-Jalpaiguri under Power House CCC

Sir,

I, Ranadip Mazumder, S/O :-Late Kalipada Mazumder , AE & Station Manager, Power House CCC , WBSSEDCL empowered by The Indian Electricity Act 2003 amended on 2007 do here by writing to report a serious incident that occurred on 09.10.2024 at Baikuntha pally (near Kali Mondir) , Dis:- Jalpaiguri, which I believe warrants immediate attention and investigation. The incident involved an accident by a Vehicle No(Scorpio):- WB20 / AG2119 with 8 Mtr PCC pole of our electrical installations, that caused significant damage to WBSSEDCL's property and public safety.

As information received from the accident location at 8.10 AM, Our technical team attend the spot immediately at 8.25 AM and found that 01(One) 8 Mtr PCC pole broken & damage of 50 mtr LTOH with damage of other electrical installation due to the accident with the said vehicle. Restoration of Power at the said location completed at 12.45 PM by replacing the damage Pole and rectification of other tit bit work.

The total financial losses caused due to this accident are approximately Rs. 28500.00 (Twenty eight Thousand Five Hundred) only.

Given the potential risks and significant financial implications, I kindly request you that a FIR be registered regarding this accident against the said Vehicle No(Scorpio):- WB20 / AG2119. Your prompt attention to this matter is crucial to ensure the safety of the community and the protection of WBSSEDCL property.

This is for your kind information and further needful action please as per law.
