I Mahadeb Das, the above noted complainant beg to inform you that on st 10.10.2024 at about 05 hrs, few antisocial persons in the leadership of Md. Siraj noted above were drinking alcohol & other intoxicated substances and abusing each other in filthy languages, in front of our let-out shop of our tenant Samad Kumar (corner of Deb store Grocery shop), ward at 2 No Tyotinagar colony, and when we and my younger brother namely Trinath Das (32) S/o Lt. Ranjan Das, protested, the above noted alleged persons namely (1) Md. Siraj S/o Lt. Md. Bishe of 2 No. Tyotinagar colony, ward No. 4 SMC, P.O & P.S-Siliguri Distt-Darjeeling alongwith his associates namely (2) Md. Amir @ Bantu S/o Md. Hasim, Permanent resident of Rangarij, P.S-9stampus, Distt-Uttar Dinajpur & others, took out sharp cutting shaving blades from their pocket and attacked on us. My said younger brother namely Trinath Das & me received severe injury on our persons and immediately shifted to Siliguri Distt. Hospital by one of eyewitness namely Pintu Saha S/o Manu Saha of 2 No. Tyoti-Nagar colony, ward No. 4, P.S-Siliguri, and we treated ourselves here.

So, please take necessary action against the above noted alleged persons & their associates.
