Respected Sir,

We the above named complainants would like to draw your kind attention to a matter that we own shops side by side at Champasari More, Nivedita Road, Pradhan Nagar, and Dist. Darjeeling. That at about 7.20 P.M. at evening when we were at our shops attending customers, suddenly one person named Niraj Singh came to our shop in drunken condition and started shouting to us and was using vulgar languages towards us without any reason. We came out from our shops and asked him why he is making nuisance in front of our shops. Suddenly he without any proper reason pushed us and started to beat us with fist, kicks and slapped us. We somehow tried to stop him but he threatened us to kill us if we do not pay him 50,000/- (Fifty thousand rupees) as donation

for 'Durga Puja' as he is the President of 'NAVANKUR SANGHA' and nobody can do anything to him as he has strong political connections. But we denied him to pay any donations, and then suddenly he started to break our shops with bamboo stick and threw stones towards us & our shops and threatened us that if we do not pay the claimed donation then he will close our shops and will kill us as he has good relations with local anti-social elements. On seeing that some other locals and nearby shop owners rushed to our shop for our help, then the accused person named above fled away.

Sir, we are common peoples within the Jurisdiction of Your P.S. area. We peacefully run our shops following all the laws. On this sudden attack and extortion demand we are very shocked and in a great fear that the accused person may harm us and may further damage our shops in future. With our utmost respect we urge you to kindly to take necessary legal actions against the person NIRAJ SINGH with as soon as possible.
