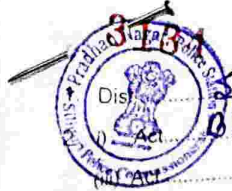

Sir,

In producing herewith four (04) accused persons namely (i) Suleman Haque (24 yrs) S/O Samsul Haque of Vill- Anandamoyee Colony, Champasari, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Krishna Subba (30 yrs) S/O Late Ganga Subba of Gurung Busty, near Ram Narayan Math, PS- Pradhan Nagar, Dist.- Darjeeling (iii) Aftab Mansuri (25 yrs) S/O Jahar Mansuri of Malli, PS+Dist.- Kalimpong and (iv) Budhha Tamang (40 yrs) S/O Sonam Tamang of Salugara, Fafri, PS- Bhakti Nagar, Dist.- Jalpaiguri under arrest and the following articles under seizure viz :- (i) one iron made hammar measuring 10 inches including its wooned butt (ii) One iron made sharp cutting weapons locally called as Tolowar measuring approx 33 inches in length including its wooden butt (iii) One iron made sharp cutting weapon locally called at "Hasua" measuring 23 inches in length including its wooden butt (iv) One iron made weapon locally called as "Hasko" measuring approx 19 inches in length (v) one iron made weapon locally called as "Sabol" measuring 22 inches in length (vi) one iron made weapon locally called as "PLUS". I, ASI Prabal Sarkar of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted 04 (four) arrested accused persons and one of Sudesh Khati of Gidde Pahar, PS- Kurseong, Dist.- Darjeeling and Bipul Sonar of Ratanlal Busty, PS- Pradhan Nagar, Dist.- Darjeeling and others 04/05 unknown miscreants who involve in this crime to the effect that on 07.10.24 at 01.25 hrs received a specific source information that about 10/11 miscreants equipped deadly weapons assembled at below Mahananda Bridge, Ganesh Ghosh Colony under PS- Pradhan Nagar, Dist.- Darjeeling and are taking preparation for committing Dacoity at Bagha Jatin colony and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 404 dated 07.10.24. As per your kind order and direction, I accompany with SI Bandhan Roy, ASI Biplab Kr Das, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Himachal Colony under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for their escape. I also informed one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling over mobile phone and requested him to come to Ganesh Ghosh Colony for the purpose of videography if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer SI Biswadeb Barman of Pradhan Nagar PS and requested him to come to Ganesh Ghosh Colony to accompany with us. At around 01.45 hrs we arrived at Ganesh Ghosh Colony and after a while SI Biswadeb Barman and his team and the above mentioned videographer reached there and accompany with us. I briefed them properly sharing the information in hand. Then, I contacted with my source and from a considerable distance he pointed the place where the miscreants were assembled. Then, I requested two independent witnesses namely Akash Saha S/O Subhash Saha of Battala, Samar Nagar, DJ More, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Dipak Barman S/O Late Sarbananda Barman of Ganesh Ghosh Colony, PS- Pradhan Nagar, Dist.- Darjeeling and I shared the information with them and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed.

Thereafter, we proceeded towards below Mahananda Bridge and cordoned the place with due care and cautioned and from a considerable distance we noticed that some persons were were assembled there and they were whispering in a low voice. On seeing police personnel approaching towards them they tried to flee away from the spot by crossing Mahananda river but on hot chase we managed to apprehended above noted 04 (four) accused persons while 06/07 others managed to fled away from the spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered the above noted weapon of offence from their joint possession.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such dead hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparation for committing Dacoity at Bagha Jatin Colony and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 03.20 hrs to 03.45 hrs in presence of independent witnesses and duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling as per norms of BNSS and brought all the four (04) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation. From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted four (04) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit Dacoity in a nearby affluent area at Bagha Jatin Colony and its surrounding areas. On prolonged interrogation all the arrested accused persons disclosed the name and address of two involve accused persons namely Sudesh Khati of Gidde Pahar, Kurseong and one Bipul Sonar of Ratanlal Busty who also present there and managed to fled away from the spot.

Under the above circumstances, I pray before you that a specific case under proper section of Law against may kindly be started against the above noted four (04) arrested accused persons namely (i) Suleman Haque (24 yrs) S/O Samsul Haque of Vill- Anandamoyee colony, Champasari, PS- Pradhan Nagar, Dist.- Drjeeling (ii) Krishna Subba (30 yrs) S/O Late Ganga Subba of Gurung Busty, near Ram Narayan Math, PS- Pradhan Nagar, Dist.- Darjeeling (iii) Aftab Mansuri (25 yrs) S/O Jahar Mansuri of Malli, PS+Dist.- Kalimpong and (iv) Budhha Tamang (40 yrs) S/O Sonam Tamang of Salugara, Fafri, PS- Bhakti Nagar, Dist.- Jalpaiguri and Sudesh Khati of Gidde Pahar, Kurseong, dist.- Darjeeling and one Bipul Sonar of Ratanlal Busty, PS- Pradhan Nagar, dist. Darjeeling and others 04/05 unknown miscreants and arrange for its investigation.
