It is pertinent to mention here that our land

has been recorded in our name vide L.R. No.
4726 and 4721 by the appropriate authority.

But unfortunately one Sri Romesh Saha, S/o
Ramchandra son of Champauni who is a very
influential person and businessman and proclaimed

dealer is trying to distract my possession. He often with his henchmen came to my land and told me to sell the land to him, otherwise he will evict us from my land forcefully. I and my co-owner several times told them that the land belongs to us and we were not interested to sale the property to him, or any one person nominated by him.

Yesterday (6/10/2024) said Ramsh Sah and his associates came to our landed property with dangerous weapon and threatened us that if we would not transfer the property to them then they will evict us from our land forcefully. And today again they came to our land at about 7 AM and then after 9 O'clock with his people and again threatened me, when I raised objection then said Ramsh Sah and his few associates insulted me and tried to get me out and my co-owner from our land forcefully.

Now I am lodging this complaint before you seeking you to take legal action against said Ramsh Sah and his associates and oblige.
