I, Sri Karambix Singh, s/o Sri Jay Mangel Singh of
Makhal Pally, Post-PS - Siliguri, District. Desjallying do
hereby lodge this complaint to the effect that

I am the owner of one piece and parcel of land measuring
5 (five) Katta at mouza - Mandaleguri within your jurisdiction.

Along with the co-owner Sri Bishay Kumar Mittal, s/o
Manindra Prakash Mittal of Senoke road, Siliguri by virtue
of one registered deed of sale being document No. 04030
2725 for the year 2007, which was first published on
2024 but it was not registered on 16/07/2007.

We were in possession of land since 2007 and purchased
it from Sri Bishendra Singh. Being the owner we had
constant boundary wall over my land in 2007 and paying
the rent and taxes.

It is pertinent to mention here that our land
has been recorded in our name vide LR. Khatian No.
4720 and 4721 by the appropriate authority.

But unfortunately one Sri Ramesh Saha s/o
Ramchandra son of Champawari who is a very
influential person and businessman and proclaimed

Yesterday (6/10/2024) said Ramesh Sah and his associates came to our land property with dangerous weapon and threatened us that if we would not transfer the property to them then they will evict us from our land forcefully. and today again they came to our land at about 7 am and then after 9:00 clock with his people and again threatened me, when I raised objection then said Ramesh Sah and his few associated assaulted me and tried to get me out and my co-owner from our land forcefully.

Now I am lodging this complaint before you seeking you to take legal action against said Ramesh Sah and his associates and oblige.
