That Sir, on 06.10.2024 around 6:10 p.m. I was at my home. My bother called me to come at Thokkar More. When I reached there, suddenly my both brother came and attcked me. They started beating me with iron rod before I could understand anything. They also thretended me by using filthy languages that they will kill me anytime. I got injured at my head and somehow I escaped from them. I immediatley run to Siliguri District Hospital and took the necessary remedy from there.

That Sir, This is not done for the first time, they have tried such antisocial activities several times these may cause my life at risk. I became bound to writting this FIR to make them punish as per law.

Therefore I urge my complain before you to kindly look into the matter and take necessary legal action against them at the earliest from your valuable end.
