Respected Sir,

I, Shipra Rani Paul, W/O - Anil Nitai Paul, resident of 12, Bimal Saha Sarami, Hadimpara, Siliguri, District - Darjeeling, Ward no-12 (SMC), want to bring to your kind notice, that my younger son, Koustav Paul, met with an accident on 4/10/2024 in college para, ward no-17 (SMC), near the water tank at around 7:30 PM IST. He was in his bike heading towards Siliguri Pharmacy where Mr. Apu Kumar Dey, resident of Dakshin Shantinagar, P.S. - Bhaktinagar, Siliguri was riding the scooter with R/No- WB74AS3758 come from the opposite side and hit my son. Post which, my son was admitted to Anandaloke Nursing Home, Siliguri, in very critical condition on the same day with several fractures in his face and forehead and multiple injuries on the head. He underwent an operation in his face because of this incident. After 6 days of continuous treatment in the CHDU unit with several specialized doctors, we discharged and brought him home on 10/10/2024. He has not completely recovered yet and still going through medication and some treatment under Doctor's supervision.

Because of this incident, my son went through several physical damage and my family is going through a very tough time and mental harassment. Therefore, I want necessary and immediate action taken on Mr. Apu Kumar Dey whose phone number is 83710-23102. Koustav Paul's Pulsar Bike No. is 24BH2684B.
