Subject - Urgent FIR for assault, harassment, evidence
tampering and impersonation by security guard
and accompanies

Respected Sir,

I, Prayoshi Saha, a resident of Bhakti nagar, am
writing to lodge an urgent FIR on behalf of my friend,
Om Jaiswal, who is currently hospitalized at Neetha Getwel
following a brutal assault by the security guard and
his accompanies during the Durga Puja celebrations on
12/10/2024 at around 4:00 AM near the entry gate of
Neetha Getwel.

Om and I were visiting a Durga Puja pandal and we
were just having a normal verbal disagreement on a
certain topic and then a security guard began harassing
us without any reason. He started recording us without
our consent, making us uncomfortable. When Om confronted
the guard, asking why he has recorded us, the guard
became aggressive. He attacked Om with a stick, causing
serious injuries and also pushed me in the process. Om
sustained multiple injuries and had to be rushed to the
hospital in a state of senselessness.

Things escalated further when Om's friend arrived to help
us. The security guard called a group of goons to
the scene. These goons, in collaboration with the guard,

stopped Om's friend and forcibly deleted all the videos and photos which his friends had recorded on their phone. The footages contained all the wrong doings of the guards. Shockingly, some of the goons even impersonated as police officers to intimidate us and obstruct justice. This all had happened before the arrival of the police.

Given the severity of the incident - including assault, harassment, destruction of evidence and impersonation of law enforcement - I request that immediate and strict action should be taken against the security guard and the individuals involved.

I kindly request you to investigate the matter thoroughly and ensure that my friend Om Jaiswal is brought to justice.
