I Narendra Prasad Sharma, S/o R.P. Sharma resident of Milon More, Karai Bari, P.O Champasari, P.S. Pradhan Nagar. Dist. Darjeeling, Pin. 734003, like to inform you that on 24/9/2024 around 1.30 AM I got information over telephone from my daughter namely Sarita Sharma that my son Deepak Sharma committed suicide. Around 12.30 AM my daughter found my younger son Deepak Sharma in a hanged condition in his bed room at Milan More, Karaibari. P.O Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, Pin. 734003,

I further inform you that since one year one girl namely Shalina Thapa Mangar. D/o not known resident of Kalabari, near Shani Mandir, P.O Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, Pin No. 734003 was mentally harassing my son and forcefully compel my son to involve in physical relationship, make sex video and started to blackmail by saying that she will make public those video if not sexually satisfy her and compel my son to remain in closed room and make him detached from all family members, relatives and friends, by threatening, quarrelling, blackmailing my son every moments. For 3-4 days before of his suicide we notice some behaviorial changes after telephonic conversation with the said girl including serious mental disturbance, Fear that was induce by above mentioned girl

friend Shalina Thapa Mangar in my son and even stop taking any food and water and finally compel my son to commit suicide. That before one hour of incident i.e, on 23/09/2024 around 11 PM my son said to my daughter Sarita Sharma that "if anything unnatural happened to me, my Girlfriend Shalina Thapa Mangar will be responsible" and asked my daughter to charge that girl.

After that with a little hope to save my son my daughter along with my another daughter namely Sujata Sharma on 24/09/2024 at around 2 AM brought my son at North Bengal Nursing home at Nivedita Road, Siliguri and Dr. declared him as dead. Under the above circumstances I plead for justice before you and please take necessary steps to punish the culprit.
