I M.D. Shamsuddin Ansari, s/o. Md. Sultan Ansari resident of Sameer Nagar, Ward No-46 of S.M.C P.O. Champareri, P.S. Pradhan Nagar, Dist- Darjeeling do hereby beg to inform that my daughter Nikhat Parween with name Soni was at home on 04/10/2024. She went to sleep at night at home in her room. But early morning at about 4:00 A.M on 05/10/2024 she was not at home. All family members looked for her here and there but could not find her. We went to Railway Station and bus stand but no trace of her.

In morning we searched her at all relatives but could not find her. I then lodged a missing diary before Pradhan Nagar Police Station on 05/10/24 which was diaries being Pradhan Nagar P.S. GDG No- 292/24; dt- 05/10/24.

Sir, on tracking the mobile number of my daughter (9832086625) by Pradhan Nagar Police Station. it was found that she was in contact with a mobile number 9236156820 from 29/9/24 till 01:00 A.M. of 05/10/24. On tracing the details it was found that the said mobile number was registered in the name of one Ranjeet Rajbhar, s/o. Laxmi Prasad of Shastri Nagar, Maharaigari, P.S. Maharaigari, Dist. Azamgarh, Uttar Pradesh. We came to know that said Ranjeet Rajbhar was in contact with my daughter through mobile game "Free Fire Game" for last few months. He had come to Siliguri on 29/9/24 and stayed in

Sovana Lodge at Pradhan Nagar and since then was in contact with my daughter. Said Ranjeet Rajbhar with ill motive and ill intention gained the faith of my daughter and persuaded her to go with him. Then on the night of 04/10/24 - 05/10/24 at about 12:00 A.M to 02:00 A.M he came near my house and induced my daughter to go with him and took my daughter with all her jewellery and money at home when all family members were sleeping.

Sir, on 08/10/24 I reached Maharashtra, Azamgarh in search of my daughter and went to Maharashtra Police Station and informed them about incident. The Maharashtra Police took me to the home of Ranjeet Rajbhar at Shertnagar but he was not there, father of Ranjeet Rajbhar said that he is not in contact of them. From local people it was learnt that said Ranjeet Rajbhar is not a person of good character. Maharashtra Police assured me that whenever they get information of Ranjeet Rajbhar and my daughter they will inform me. I returned back home thereafter.

Sir, said Ranjeet Rajbhar by deceitful means induced my daughter and took her with all her jewellery and money from my house with him. I believe that he will cause harm to my daughter and force her to any illegal activities and commit torture upon her resulting my daughter's life in danger. For last 5 days there is no trace of my daughter.
