

I Manoj Paswan, the above noted complainant beg to inform you that on dt. 13.10.2024 at about 04:30, when my son namely, Ritik Paswan @ Riti (18) along with his associates were loading a toto at Tyobingur colony, near shib mandir at that time one toto driver namely (1) Prudip Das s/o Lt. Parindra Das of locality told them to remove their toto to clear the road, since loading was going on and passage was enough to pass any toto, my son & his associates told said toto driver to pass, but he called his wife namely (2) Swapna Das and his relative namely (3) Sayan Das s/o Babram Das, and they all started abusing my said son and his associates and when they protested, the above noted alleged persons, started beating my son Ritik Das and his associates namely, Vrshat Sahani s/o Lt. Binod Sahani of Hemanto Bus colony, Near Kachua Maath, ward No. 4 SMC, h/o & P.S - Siliguri & others and said Prudip Das took out the key of his toto and forcefully hit & inserted the key on the head of my son namely Ritik Paswan and he received severe injury on his person and heated himself at Siliguri Distt. Hospital. So please take necessary action against above noted alleged persons.
