With due respect, I, Sunita Lakra, the undersigned, would like to bring to your kind notice the fact that one Subhajit Nandi, Son of Krishna Nanda Nandi of Block Cat C-2, Flat No.-2, Bananta Abasan, 193, Andul Road, Haora (M.Corp.), Howrah, West Bengal - 711109, married me on 16/01/2017 and registered the marriage on 23/12/2017 in the office of Sagarika Basu, Hindu Marriage Registrar for Howrah, Shibpur, Bantra Jagacha P.S. Area. Out of our wedlock I have a daughter named Sreenidhi Nandi born on 05/11/2017. And now present residing at Vivekanada Nagar, Near health center ward no. 42 P.O, Salugara P.S, Bhakti Nagar Pincode- 734008. Siliguri.

Initially my husband Subhajit Nandi made tall promises of a happy marital life with me, but gradually I came to know about his illegal activities. He used to defraud people by taking huge sum of money under different pretext by representing himself as influential person of high ranks. Not only this, I came to know that he has two more subsisting marriages before solemnizing marriage with me. Out of these two previous marriages, he had performed a marriage by changing his religion from Hindu to Islam under the name Rehan Ahmed.

My husband has committed cheating upon me by concealing the fact of his subsisting marriages. When I started seeking explanation regarding his marriages and work, he started abusing me brutally. He used to exploit people by seeking money in my name so that he could shield his misdeed and use me as scapegoat in his frauds committed by duping money from people while he was living with me. I am under immense trouble and fear that his criminal activities may again put me and my minor daughter in trouble.

His behavior with me had become such violent that I had to shave my head due to severe head injuries inflicted upon me by Subhajit Nandi on 28th March, 2024 at the then address at Haider Para, Siliguri. I did not report the incident due to danger to me and my daughter's life. There are multiple police complaints lodged against my husband in different police stations for his illegal financial frauds. I have no relationship with him and I denounce any complicity in any of his illegal activities. I and my daughter are becoming victims of his misdeeds. I have no relation with him at present as I don't know his whereabouts. I am hardly managing my day-to-day necessities and living a miserable life along with my minor daughter.

Kindly take strong action against Subhajit Nandi as he is a fraud and further ruin the life of other people, including women whom he may seek to marry by concealing his existing marriages.

And for this act of duty I shall always remain indebted to you.
