I Farah Amir (24) D/o Amir Hussain,

residing at Chinese Building, Near Radha Krishna  
Complex, Bankim Nagar, P.O-Sevoke Road (Via ITI  
to Tiranga More), P.S-Bhakti Nagar, Dist-Jalpaiguri  
beg to inform you that I used to work as Singing  
Dancing Girl at the Beer Bar namely "THE MASK",  
at Hotel Gateway at Sevoke Road, P.S-Siliguri,  
Dist-Darjeeling and there I came to meet with  
a customer namely Ravi Prasad and he started  
coming there regularly and spending lots of money  
over my performance and after some time he told  
me that he is in extreme love with me and he is un-  
married and want to marry me and over his  
assurance, I shifted to a rented home at Chinese  
Building, noted above under Bhakti Nagar P.S. and  
he regularly started keeping physical relation  
with me and committed sexual intercourse with  
me at daily Basis from dt. 21-08-2024 there.  
And he induced me that he is need of money and  
on his inducement, I <sup>paid in cash</sup> transferred Rs. 1,00,000/- (one  
lakh) in July 2024 and again transferred Rs.  
1,50,000/- (one lakh fifty thousands) only to Mobile  
Palace on dt. 22.08.24 to buy a mobile phone for him  
and on dt. 2.09.2024, I transferred, Rs. 23,000/-  
(twenty three thousands) only, and Rs 27,000/- (Rupees  
twenty seven thousands) only and again Rs 15,000/-  
(Rupees fifteen thousands) only and finally Rs.  
2,50,000/- (Rupees two lac fifty thousands) only in  
Cash from me, this way he took Rs. 5,65,000/-  
(Rupees five lac sixty five thousands) only and  
did not returned any money to me till now.

Later on I came to know that he is already  
married and his full name and address is, Ravi  
Prasad s/o Lt. Prabhakar Kumar, Permanent resident of  
Alipatty, Ward No. 6, P.S-Siliguri, who have now refused  
to marry me. So Please take necessary action against him
