I sri Gautam Kumar Bhaduri, residing at Sesh Basanta Path, Beside 100 Pearl Apartment Since 1996. In 2001 there was a burglary in the broad daylight, which occurred on 16th of August, but Mr Moktan thee then Officer in charge of Bhaktinagar P.S arrested all the culprits within a week and again on 2002 there were burglary in my house and again Mr Binoy Gurung, thee then officer In-charge arrested all the culprits soon. Hope this time also you will take necessary steps to arrest the culprit.

In my house, six CC TV cameras are installed but unfortunately it was switched off from 5.10.2024, 9 A.M & when my wife noticed on 7th morning, she saw the camera was switched off, from the camera recording we could see that the stolen material was in place on 5.10.2024 and missing on 7.10.2024 and due to rain our german shepherded dog was kept in house, so it is being noticed by the culprit. Moreover, one lock was not functioning, so it cannot be placed over the sliding gate, which is our usual practice.

I hope, if you check the CC TV camera of adjacent apartment owners, you may get the clear picture.
