Duty at 4:30 AM and he kept whole amount
(12,26,604=₹) to KFC Locker. Then we came
at City Center and checked our CDO footage.
Around 5:38 AM unknown person entered KFC center.
And taken whole cash amount. He wear KFC Cap.
We can't find out unknown person.

Therefore we are requesting you kindly take
necessary action regarding this theft matter and try to
recover the above amount.
