Sir,

In producing herewith four (4) accused persons namely 1. Amal Barman (18) S/o Jagabandhu Barman of Cannel More , Nawapara near Radha Krishna Mandir PS NJP Dist. Jalpaiguri 2. Bishal Roy (20) S/o Hiren Roy of Bhola More Muni Factory PS NJP Dist. Jalpaiguri 3. Md Aktar (23) S/o Md alauddin of South colony Bazar PS NJP Dist. Jalpaiguri 4. Subham Agarwal (30) S/o Lt. Sunil Kr. Agarwal of Milanpally near Children Park PS Siliguri Dist. Darjeeling along with seized articles viz

1. One iron made weapon called as " Khuria" one side carved measuring approx 2 feet from the possession of Amal Barman.
2. One iron made weapon called as "Sabal" one side sharp length approx 28 inches from the possession of accused person Bishal Roy.
3. One iron made weapon called as " Katari" front side carved measuring approx 3 feet including wooden butt from the possession of accused Md Aktar.
4. One iron made weapon called as "Dao" length approx 18 Inches including plastic batt from the possession of accused person Subham Agarwal.
5. One Electronic torch light from the PO.
6. Two Special Cigarette open packets in containing 15 pcs Cigerate from the PO.

I SI Ganesh Roy of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 6/7 persons to the effect that on the night 09.10.24 at 23-25 hrs received secret source of information to the effect that some miscreants armed with deadly weapons assembled in a dark place at Canel road Putimari under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and as per your kind direction myself alongwith, SI Tanmay Kundu , ASI Nilam Swarnakar, C/1462 Sajan Tamang, C/152 Abdul Kayum Miah, VP-13 Jamirul Islam, CV-297 Putul Roy, CV-306 Biswajit Roy, CV-824 Niru Kumar Yadav left from PS which noted in GD vide NJP PS GDE No. 543 dt. 09.10.24 with night mobile van officer SI Rana Brahma and force for Cannel road Putimari to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source on 09.10.24 at 23-55 hrs and stopped out vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the place and found a group of 10/11 persons assemble and gossiping in a dark place at that area. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we could able to apprehend the 04 (four) persons noted above and the others 6/7 persons managed to flee away from the spot. On interrogation they disclosed their identity which was not verified and they also stated that they alongwith their other associates assembled there with a view to commit road dacoity in Buses and Trucks after making full preparation on National Highway near Fulbari under NJP PS. Thereafter all the apprehended persons were searched and due to late night could not found any independent witness to present at the time of search and seizure. During searching I found and recovered the above noted articles from their possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure has been captured in videography as per provision of law . Accordingly I arrested the above noted accused persons u/s 35 BNSS. The seizure was made on 10.10.24 in between 00-15 hrs to 00-35 hrs and all persons were arrested with proper memo of arrest.

So I pray before you that a specific case may kindly be started against 1. Amal Barman (18) S/o Jagabandhu Barman of Cannel More , Nawapara near Radha Krishna Mandir PS NJP Dist. Jalpaiguri 2. Bishal Roy (20) S/o Hiren Roy of Bhola More Muni Factory PS NJP Dist. Jalpaiguri 3. Md Aktar (23) S/o Md alauddin of South colony Bazar PS NJP Dist. Jalpaiguri 4. Subham Agarwal (30) S/o Lt. Sunil Kr. Agarwal of Milanpally near Children Park PS Siliguri Dist. Darjeeling and other 6/7 persons and arranged for its investigation.
