MULTISPECIALITY HOSPITAL, SEVOKE ROAD, SILIGURI, MY
FATHER MR. NIKHIL DEY SARKAR HAD A VERY MAJOR
ACCIDENT AT P.W.D MORE, SILIGURI, ON 9TH OCTOBER
2024 AROUND 11 PM - 11:30 PM. AS PER PEOPLE AROUND
THE SPOT WHAT I HEARD IS A BIKE (DOMINOS DELIVERED)
HIT HIM AND GOT OVER HIS LEGS AND ANOTHER
BIKE GOT OVER HIS CHEST,

FIRSTLY, MY FATHER HAD BEEN TAKEN TO PARAMOUNT
HOSPITAL BY UNKNOWNS, AND THEN I HAD SHIFTED
HIM TO STAR HOSPITAL, BUT DUE TO LACK OF PROPER
TREATMENT AND MEDICAL CONSULTANCY THE HOSPITAL
REFERRED US TO ANANDALOKE MULTISPECIALITY HOSPITAL
SILIGURI.

AS PER MY KNOWLEDGE THERE WAS A DOMINOS GUY WHO
HIT MY FATHER AND MIGHT BE WORKING AT J.P. ROAD
BRANCH (INFORMATION BY LOCALS), I WOULD ALSO LIKE TO
INFORM THAT THE PERSON WHO TOOK MY FATHER AT PARAMOUNT

HOSPITAL DIDN'T DISCLOSE HIS NAME TO THE HOSPITAL AND NOR THE HOSPITAL TOOK THE RESPONSIBILITY OF NOTING DOWN THE NAME OF THE PERSON WHO TOOK THE PATIENT TO THE HOSPITAL. AFTER FURTHER DISCUSSION WITH PARAMOUNT HOSPITAL STAFF WHO ATTENDED MY FATHER THAT NIGHT I GOT TO KNOW THERE HAD BEEN FOUR PEOPLE WHO TOOK MY FATHER TO THE HOSPITAL AND THEY WERE WEARING DOMINOS BRAND TSHIRTS, BUT AFTER THE HOSPITAL STAFF TOOK MY DAD FOR TREATMENT ALL THE FOUR COULDN'T BE SEEN AT THE HOSPITAL PREMISES. I HAD ASKED THE HOSPITAL FOR THE CCTV FOOTAGE WHICH WOULD HAVE BEEN MORE HELPFUL FOR FINDING THE PERSON BEHIND THE ACCIDENT OF MY FATHER, BUT THE STAFF SAID, WILL TAKE TIME FOR GETTING THE FOOTAGE AND DIDN'T COOPERATE ON SPOT.

FURTHERMORE, I WOULD LIKE TO TAKE THE HELP OF THE N.J.P POLICE STATION IN INVESTIGATING THE MATTER AND TAKE ACTION AGAINST THE PERSON.

I WOULD LIKE TO HUMBLY REQUEST YOU TO KINDLY LOOK INTO THE MATTER AND ^{DO} THE NEEDFUL.
