

Respected Sir,

I, Rohit Prasad (Advocate), S/o. Shri Dasarath Prasad, resident of S.F. Road, Siliguri, Dist.-Darjeeling, West Bengal, Pin-734005 would like to brought to your kind information which are stated as follows:

- a) That on **14-09-2024**, I have applied for the position of "**Corporate Lawyer**" in the company named **Sandeep G Real Estate Ltd.**, located at **City Centre Block G-214** and after review my additional qualification of **CA-Articleship**, Shri Sandeep Goyal (Director) has offered me the salary of **Rs. 4,20,000/- p.a.** for a period of **01 (One) Year** for the post of "**Accounts Executive**" and assured me that after joining the "**Sandeep G family**" he will definitely promote me to the post of "**Corporate Lawyer**" and provided me an offer-letter and asked to join the company from **16-09-2024**.
- b) That upon rely on his commitment and "**Offer-Letter**" I had joined and started working in the company from **16-09-2024** as "**Accounts Executive**" and also managing and completed the Audit related works of the **Financial Year 2023-24** for **2 (Two)** more additional companies namely a) **Unity Builders** and b) **Anandi Ram Maintenance Services LLP** without expressing any kind of objection instead of that **CA Khusbu Agarwal** used to treat me as her servant and always dominating me and indulged me in her personal works and she was always showing her "**Bossy**" nature in her attitude, which leads to mental harassment and due to which I was losing my self-confidence and felt embarrassed.
- c) That there was having a close and friendly relationship between **CA Khusbu Agarwal** and **Sandeep Goyal (Director)** and due to which she was taking due advantages of getting success and promotion.
- d) That on **26-09-2024**, around **06:00 pm** in the evening after working for **10 (Ten)** days I had conversation with Shri Sandeep Goyal and asked for the position of "**Corporate Lawyer**" in the company which earlier I had applied for and expressed my objection to work as a servant for **CA Khusbu Agarwal**. He had shouted at me and told that she is also the owner of the company and I had to act according to herself and also forced me to do immediate resign without any specific reason and without my free consent and overall, without providing me the notice-period which leads to mental harassment and financial loss for me and although my rights had been hampered.
- e) That on **27-09-2024** when I asked for my salary, he had abused and threatened me through telephonic mode with dire consequences of having good-connections with the political influential persons and disconnected the call. I am enclosing herewith the offer letter for your ready reference. So, I kindly request you to take cognizance of the matter and kindly lodge FIR.
