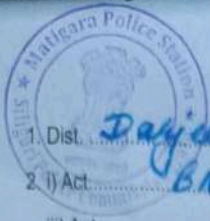

1. I, **SRI. BIMAL CHANDRA ROY**, S/o. CHHIR MOHAN, Hindu by religion, Business by Occupation, Indian by citizenship, resident of Chhoto Dhukuria Jote, P.O. New Chamta, P.S. Matigara, Dist. Darjeeling-734009, requesting you to register this written complaint and FIR against some miscreants, gundas & land mafias leaded by (1) **Sri. Pappu Roy**, S/o. Jalpaiguri for for threatening to kill my family, insulting, cheating, forgery, conspiracy, illegally & forcefully trespassing, encroachment & capturing of my recorded land property.
2. Whereas I am the absolute recorded in possession of a piece or parcel of land property measuring **08 Decimal or 05 Katha, in R.S. Plot No. 302 corresponding to L.R. Plot No. 482, situated in Rajpouri Mouza, J.L. No. 24, under the jurisdiction of Matigara Police Station, Dist. Darjeeling.** And I have been holding possessing and enjoying the said land having permanent, heritable and transferable right, title and interest therein free from all encumbrances and charges whatsoever.
3. That on today morning these said miscreants leaded by Pappu Roy have trespassed into my land property in the motive to capture my land forcefully which is totally illegal for which I had to raise strong protest. I have gently requested them to stop their illegal work and asked them on what basis you people have trespassed into my land property without my permission. They have claimed that the said property belongs to them for which I have again requested them to supply their supporting documents, deeds of Registration, money receipt, Order Copy & other relevant documents.

In this fearful situation, I would like to request you to please register this written complaint/ FIR against the said miscreants, conspirators, goons and land mafias and take strict legal action for their illegal acts and deeds, conspiracy, cheating, illegal capturing my inherited property, attempt to murder, threatening to kill me & my family by gunshot. In addition, I am requesting you to take strict legal actions against the said miscreants and restrict them from further encroachments & construction work on the above mentioned land property.
