Sir,

I do hereby lodge a written FIR to this office that I Naveen Kumar, Aged-M/33yrs, S/O- Lt. Mahavir, Present address at RPF/Post/Rangapani. On 11.10.2024, I was conducted performing duty at Bagdogra section. On 12.10.2024 after completed performing duty at about 12:20 AM, I reached Mela festival near RPF/POST/Bagdogra. As soon as I reached near Orchestra (Arkestra) in Mela, in the meantime 10-15 unknown persons attacked me with chair and Bamboo without any reason and I tried to self-defence but I was not successful and they continue to beat me. After some time, some local police personal saved me and detained 03 persons out of 10 - 15 persons. Thereafter, the apprehended 03 person took your police station for further action. After that, I immediately went to the Rural Hospital of Bagdogra for further necessary treatment, as during the attack I suffered serious injuries on the Left face, head, chest and both elbow. During attacked I lost my gold Chain weight 15grams, money wallet with 5000/- cash and service Identity card

I have never seen the peoples who attacked me before this incident and I do not know anything about them

Now, I produce a written FIR with medical report for you taking necessary legal action as per provision of law.
