Sir,

I, ASI Utpal Das s/o Mahadeb Das of Bhorer Alo Police Station, SPC do hereby lodge a written complaint to the effect that today on 14.10.2024 at about 10.25 hours while performing my mobile van duty under Bhorer Alo PS area vide GDE No. 428, Dated 14.10.2024 and M.C.C No. 1586, Dated. 14.10.2024 received the information from ASI Gokul Sarkar, Duty Officer of Bhorer Alo PS, SPC that one motor accident had occurred on Canal Road near Gate Bazar under Bhorer Alo PS and directed me to visit the P.O for taking necessary steps. Accordingly after receiving the information I along with force moved towards Canal Road near Gate Bazaar and found one red color Hyundai i20 bearing registration no. WB 74X 0724 in damaged condition beside the Canal Road occupied by one driver and one person in injured and unconscious condition.

The driver of the damaged vehicle was identified as ASI Samarjit Ghosh s/o Late Jitendra Chandra Ghosh of Pilkhana Colony, P.O Jalpaiguri, PS Kotwali, Dist. Jalpaiguri presently posting at Ambari OP under Bhorer Alo PS, SPC and the other person as Dhola Barman (46) s/o Late Bishto Barman of Joldumur, Sahupara, PO Sahudangi Hat, PS Bhorer Alo PS, Dist. Jalpaiguri.

During preliminary investigation at the PO, it came to light that at about 10.15 hours one unknown four-wheeler coming from the Gajoldoba side with rash & negligent driving dashed the above said vehicle coming from the opposite direction. As a result, the vehicle got damaged and the driver and other person received grievous injuries on their persons. The local people tried to chase the offending vehicle but the vehicle managed to flee away from the spot. Thereafter, I along with the help of local people shifted the injured persons to nearby Hospital for their medical treatment by Traffic Ambulance of Canal Road Traffic, SPC. I then brought the damaged vehicle to the PS compound and kept it for safe custody.

Hence, I request you to kindly start a specific case against the driver of the unknown vehicle under proper section of Law and arrange for its investigation.
