Respected Sir,

With due respect I would like to bring to your kind notice that today (14-10-2024) at about 7 am few of my neighbors called us over phone and informed us that two unknown persons were seen jumping out of our above said building from the south eastern gate after taking out two bags full of computer systems from our premises.

That upon their objections and hues and cries the above said two unknown persons ran away leaving behind the said two bags.

Hence upon such knowledge I and my husband rushed to our above said building and found that the door latch of the room at ground floor (near the stairs) was broken. And several computer systems, other valuable items and documents were found missing from our said room; asides the items left behind. Moreover, the water pump was also found missing from the premises amidst various items kept in the northern gallery of our building.

That one of our neighbors (opposite building) also informed that on 13th of October 2024, Sunday morning at about 5 AM, they saw two persons carrying away few bags from our said building.

Sir, due to Pooja Vacations we were absent in the said building since Friday night and presently no one resides at the said building.

Sir, on this behalf I request you to look into the matter and take necessary action against those burglars and help us recover our stolen items.
