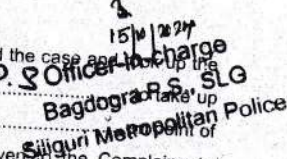

I, ASI UB 503 Md Akhter Hussain, of Bagdogra Traffic Guard, SPC performing Traffic regulation Duty at Rupsing Jote, (College More) Traffic Signal Point with C/1399 Rakesh Barman & CV-737 Krishna Singha beg to lodge a written complaint that on 15-10-2024 around 19:00 hrs a vehicle bearing Registrion no BR 33AW 8385, Coming from Shivmandir Medical More side towards Bihar more. The said car doing signal violation at Rupsing Jote Traffic point & stopped the car and asked the Driver to show the vehicle papers and Driving Licence but he denied producing the papers. The vehicle driver namely **Rohit Kumar Mallick, S/o- Dinesh Mallick of Po- Geeta Deodha, PS-Hasanpur, Samastipur, Bihar, Pin-848208, Mob-7488363561** is found drunken condition during that moments. It is also found that on POS Machine his vehicle pollution paper is invalid. At that time bring the Breath analyzer machine from Bagdogra Traffic Office, where he was checked with Breath analyzer Machine & confirmed his drunken Condition (37mg/100ml). The said driver disrupting and blocking the free flow of traffic, causing hindrance and danger to the General Public, Traffic Police personnel and other plying vehicle. After that said driver namely Rohit Kumar Mallick, S/o- Dinesh Mallick of Bihar caught my Uniform collar & hitting an on duty police officer upper portion of my right leg, Chest and also hit my left hand shoulder to discharge my Govt Duty.( My Medical prescription enclosed herewith).

Thereafter I also handover the said Driver to the Bagdogra Police Station, Hence I would therefore request you to kindly start a specific case under proper section of law against the said driver Namely **Sri Rohit Kumar Mallick, S/o- Dinesh Mallick of Po- Geeta Deodha, PS-Hasanpur, Samastipur, Bihar, Pin-848208, Mob-7488363561** and oblige.
