Respected Sir,

I, **Smt. Molina Roy Singh**, Wife of Sri Subodh Singh, resident of Vivekananda Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge an F.I.R. against against Mantu Ghosh (Bacha), Son of Madan Ghosh and Renu Ghosh, Daughter of Madan Ghosh, both are resident of Vivekananda Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effect that since 09-10-2024 the above-named persons and their minor son had been pelting stones in my house at night which is under construction and on 11-10-2024 when I and my husband were not at my home then taking advantage of the same, the minor son of the above-named persons on their aid and abetment entered into my under construction house at night and stole some electrical items.

On 12-10-2024 at about 4:30 pm when I along with my college going son protested about pelting of stones at night by them at my house and about stealing of some electrical items by their minor son then they became angry and had hot altercation in between us and thereafter they abuse me and my son in filthy languages and physically assaulted me and my son.

The above-named persons also gave life threat to me and my son. Delay of one day in lodging the F.I.R. over the said incident was due to the intervention of the respected people of the locality to have amicable settlement between us but in vain.

So, therefore, I humbly request your goodself to take stringent legal action against the abovenamed persons and booked them under specific provision of law for the time being in force.

I shall remain ever grateful for the needful and be obliged thereby.
