Respected Sir,

With due respect I Sri Ratan Roy s/o Sudhir Roy  
residing at M.E.S choupatti, near Kali Mandir, P.O:- Hasimara, P.S:- Jaigaon,  
Dist:- Alipurduar, P.Si-735215, do hereby lodge this written complain with  
the allegation that, I am the owner of schedule below land, majoring  
11 Katthas 7 chatak (Eleven katthas seven chatak) by virtue of inheritance  
of R.S Khatian no. 622, Dag 472, Dag 26 (LR), Khatian 203, 204, 205 (LR)  
J.L No. 02, Mouza Dabgram, Sheet No:- 8 (R.S), 41 (L.R). Along with me my  
sister namely Babli Roy and Tapan Roy are also the owners of the  
above mentioned land. Both my sister and brother have given me the  
right and authority to look after, supervise and sell the above mentioned  
land vide GPA deed no. 2093, dated 16th July, 2020 at the ADSR,  
Alipurduar.

That Yesterday ie, on 15-10-2024 at about 11:30 ~~pm~~ am,  
Dilip Das whose mobile number is 9609944012, manager of Vishal  
Cinema Hall, along with other miscreants entered my land and  
sculked, hit the labours working in my land and damaged the gate  
and broke it and threw it away. The person namely Dilip Das  
called me on phone and threatened me not to enter <sup>in</sup> my land  
in future and said that he ~~was~~ come to threaten me and break  
and damage my gate and property as his boss namely D. Surya  
Singh s/o. Pappu Singh of Church Road Siliguri and ~~others~~ others  
instructed him to do so. They all along with their associates gathered in  
front of my scheduled land again later with deadly weapons and  
tried to occupy my land. I along with my neighbours came to the  
spot and protest the noted above persons, but they became furious  
against me and tried to kill me, but somehow I saved my life  
and fled from there. They even threatened me with dire

P.T.O

sequences that within few days they occupy the schedule land by hook and crook.

That due to the aforesaid unwanted situation I feel that at any moment the noted above persons along with their associates forcefully occupy my schedule land. And therefore, finding no other alternative, I lodge this written complaint against the noted above persons, that, your good self be please to save my life and property from the life of the noted above persons and to take necessary legal actions against them and oblige me for the ends of justice.
