- III) Sri Sagar Rai, S/o Nabin Rai of Bandh Basty, P.O. & P.S. Pradhan-Nagar, Siliguri, Dist. Darjeeling, West Bengal and others. Enelda Keyew

With active support and co-operation of the Manager WBSEDCL, Pradhan Nagar and his Sub- ordinate stalfs and others, who installed Electricity Meter on title suit land and open land without any structure. Dear Sir.

Requesting you hereby that take appropriate lawful action against the aforesaid culprits as per the provision of the law of the land and also requesting you hereby that arrange to remove the electricity meter from my said land and for the same please allow me hereby to state the following facts for your kind consideration and perusal:

A) That the aforesaid culprit No. 1 Aasrel Topno, many times asked me to sell out my said land on a through away price, which I refused and from that day the aforesaid culprit No. 1 became my hardcore enemy and he started to harass me and hatched a criminal conspiracy to dislodge me from my said legitimate land and he is the main financer to aforesaid culprit No. 2 namely Sanjay Ekka, who filed being the attorney of aforesaid culprit No. 4 a title suit vide No. 189/2016 in the court of Civil Judge (Jr. Division) at Siliguri on the basis of illegal land khatian of 99 decimal, as the aforesaid culprit No. 4 in the aforesaid title suit case that she already sold 50 decimals of land to the other person than how can she the a khatian holder of 99 decimal land.

That I filed a petition for the delist of the Smt. Saniaro Mindane @ Saniaro Munda land khatian to the DL & LRO, Dist. Darjeeling and the matter is still pending with the concerned authority.

- B) That as per the law of the land, illegal omission commission committed by the junior sub-ordinate staff and for the same the higher authority of the concerned department is also responsible and deemed as a culprit.
- C) That as per the established norms in the WBSEDCL no electricity wire can be erected from the electricity pole by using bamboo pole.
- D) That as per the established norms in the WBSEDCL the electricity meter cannot installed on the open land nor on the third persons wall.
- E) That the said land is under sub-judice of the aforesaid Hon'ble Court and consent of the aforesaid Hon'ble Court is mandatory for installing electricity meter and the unfortunate fact is the aforesaid culprits did not obtain the consent of the aforesaid Hon'ble Court for the same.
- F) That as per established norms in the WBSEDCL third party cannot applied for the installing the electricity meter without the consent of the actual and real landlord.
- G) That I purchased the said land along with my brother in –law in the year 2002 measuring about 1 acres of land.
- H) That the office of the BL & LRO, Matigara issued land khatian of the said land in favour of myself and my brother in- law namely Karnilush Kujur(Oraib) S/o late Johan Kujur.
- I) That the previous BL & LRO of the Matigara Block, Matigara bypassing all the legal norms and delisted my khatian in favour of aforesaid Smt. saniaro Mindane @ Saniaro Munda, W/o Sri Sevan Munda, area approx 99 decimal

- NB: The aforesaid Smt. saniaro Mindane @ Saniaro Munda, W/o Sri Sevan Munda in writing acknowledge in the title suit case No. 189/2016 that she already sale out 50 decimal of the said land and how the previous BL & LRO issued land khatian of 99 decimals to the aforesaid Smt. saniaro Mindane @ Saniaro Munda.
- J) That the previous BL & LRO knowingly or unknowingly issued the land khatian of Smt. saniaro Mindane @ Saniaro Munda without legal status of the aforesaid Smt. saniaro Mindane @ Saniaro Munda as per the succession law is/was in force.
 - NB: The aforesaid Smt. saniaro Mindane @ Saniaro Munda is not entitled to in heritage the property of her late father as per the succession act guiding the schedule tribe community.
- K) That the aforesaid Sanjay Ekka and Aasrel Topno for the last several year through mediators and in person several time offered the through away price for the my said land and every time I refused.
- L) That the aforesaid Sanjay Ekka and Aasrel Topno threatened me many times and tried to capture my said land forcefully and I informed the concerned immediately and copy of the said petition attached herewith for your kind consideration and verification.
- M) That the aforesaid Sagar Rai is also part of the said conspiracy and arrange bamboo pole to erect electricity wire from the WBSEDCL electricity pole.
- N) That the aforesaid contractor of the WBSEDCL and his worker was fully aware that they installing the electricity meter illegally as there was no structure pucca or kuccha is/was standing on the said suit land.

O) That the main conspirator is aforesaid Aasrel Topno who used to finance the all the said illegal activity and through the aforesaid Sanjay Ekka, the said Sanjay Ekka is the attorney of the aforesaid Smt. Saniaro Mindane @ Saniaro Munda.

In the light of aforesaid facts requesting you hereby that use your good office and arrange to remove the electricity meter from my said land and also requesting you hereby that take appropriate lawful action against aforesaid culprits as per the provision of the law.

Please do the needful and oblige me.
