Subject: FIR Regarding Accident Caused by a Drunk Scooty Driver

Respected Sir/Madam,

I, Ratan Dutta, S/o Sri Rabi Dutta, residing at Baghajatin Colony, ward No -45/8, Pradhan Nagar, Siliguri, would like to report a letter regarding an accident that occurred on 14th October, 2024 at around 8:20 p.m at Baghajatin Colony near a medical shop, (Medi Zone).

My mother, (Rekha Dutta) was standing at a medical store when a Lady named Piyali Barman w/o chanchal kumar Das, seemingly under the influence of alcohol, riding a scooty with registration number WB74AS7857, hit my mother from behind. According to local witnesses, the scooty was being driven recklessly at a speed of around 50 km/h. As a result of the impact, my mother fell down and was immediately rushed to the hospital at Shanti Nursing Home, where it was confirmed that she has sustained a serious injury, specifically a broken pelvic joint, later as serious basis we admitted her at shanti nursing home on 15th october 2024.

We request you to kindly take immediate action against the scooty driver responsible for this accident and ensure proper legal proceedings.

Enclosed are the relevant documents, including the medical report.

I trust you will investigate this matter thoroughly and ensure justice is served.
