11 am, I admitted my pregnant wife Smt. Riya Gupta in
Siliguri District Hospital for delivery of baby. The Hospital
authority checked all the report & her & admitted in New
Labour Ward, on same day almost 4:30 pm when my
wife get pain, then Nurse & Hospital staff called me &
said me that they take my wife in O.P.D section for
delivery. But after some time when my wife coming to
consciousness that time the on duty Nurse said that she
birth a baby boy, but few minutes later they said that the
new born baby is dead the birth a dead baby, after some
time they called me & my family members to saw the
dead child. I saw that time my wife said that the child was
crying in the time of birth & the death of child by their
negligence, the doctor & Hospital staff give her not proper
treatment, the doctor & Nurse create pressure upon my
family members to signing some papers & mention in paper
that the child was dead in time of Birth. The doctor &
all the O.P.D staff & Nurse told me that they gave us
the dead baby next morning after complete their paper
work & the formalities of the Hospital.

When I with my family to create pressure upon them to search my baby then the Hospital staff misbehaves with my family members as well as me, they said us "Masa baccha kaha kya karoge". Now I am hopeless & my wife is in mental stress & she believed that the doctor was the reason of their negligence. So I requested to you that kindly take strict action against all the on duty staff of District Hospital of Soligri of New born baby section, Nurse, operation theater staff, Doctor & security guards Help me to take justice. I am highly obliged with you.
